- 1. The In -Service doctor shall carry the pay scale of Rs.9300-34800 plus grade pay as admissible under rules.
- 2. The in-service doctors shall be allowed to participate in the selection process only the prior permission of the Administrative Department, for the purpose, they should route their application forms through Administrative Department. No advance copy shall be entertained.
- b. For Non-PSC candidates (Not in-service):-
- 1. The Non- PSC doctors shall be appointed as per SRO 24 of 2013 and shall be paid a consolidated pay equal to the post of Dental Surgeon in the Health Department as per the SRO-93 of 2009 dated 15-4-2009 plus DA
