In pursuance of Govt. Order No. 706-HME of 2007 dated 11-01-2007, modified vide G.O. No. 601-HME of 2007 dated 10-09-2007 with modification vide 726-HME of 2007 dated 23-10-2007 and corrigendum to G.O. No. 726-HME of 2007 dated 23-10-2007 and selection policy pertaining to House surgeons vide Govt. Order No. 706-HME of 2007 dated 11-01-2007, an advertisement Notice was issued under endorsement No. IGGDCJ/Estt/GD/2942-49 dated 06.10.2023, a comprehensive merit list was prepared on the basis of academic merit and written test marks. As per merit list and preference given, counseling of eligible bonafide candidates of this college and external candidates. Sanction is hereby accorded to the engagement of the following doctors as stipendiary House Surgeons in the department shown against each for a period of one year in Indira Gandhi Government Dental College/Hospital, Jammu:-

This engagement of House Surgeons will be on tenure basis for a period of one year only on following terms and conditions:-

1. The House Surgeons will be whole time basis and will not do any private practice;
2. During the tenure period of House job he/she will be governed by rules, regulations, & discipline on the same analogy as is applicable to other doctors of J&K Service Conduct Rules, 1971;
3. During the tenure as House Surgeons, he/she shall be entitled to casual leave for 15 (fifteen) days only which shall be availed by the House Surgeons proportionately during the year. The House Surgeons availing excess leave during the period of House job shall have to repeat the period in his/her own interest without any stipend only on compassionate grounds with documentary evidence and recommendations from the concerned HOD, the undersigned shall issue the extension order after satisfying with the applicants compassionate condition and recommendation of concerned HOD. Experience shall be given, but there shall be no stipend for the period House Surgeon remains on leave except 15 days casual leave.
4. The services of the House Surgeon shall be terminated by the Principal, Indira Gandhi Government Dental College, & Hospital, Jammu without prior notice, if any doctor indulges in strike or any other activity which is against the interest of institution and patient care or unsatisfactory report received from concerned Head of the Department against any of the doctor;
5. The stipend for first month shall be kept withheld and the same will be released only after successful completion of full tenure of House Job.
6. The House Surgeon shall be put on emergency duties in the Hospital on monthly rotational basis issued by the Medical Superintendent, Govt. Dental Hospital, (IGGDC), Jammu and if any House Surgeon found disobeying the orders shall be entitled for termination from the said job under rules;
7. The House Surgeons are entitled for stipend as per Government order issued by Health and Medical Education Department, J&K from time to time.
8. The House surgeon shall maintain a record of his/her work on a record book.
9. He/she shall join the Department within a period of 7 days from the date of issuance of this order, failing which his/her engagement shall stand cancelled without any further notices.
10. No House Surgeon shall be allowed mutual exchange of speciality.
11. No House Surgeon shall allotted hostel accommodation
12. All the House Surgeons shall submit an affidavit duly attested by First Class Judicial Magistrate to the effect that:-
 - e) He or she has not undergone House Job in any specialty previously within or outside the State and will not indulge in strike or any other activity which will hamper the hospital service/patient care during the period of House Job.
 - f) The engagement as House Surgeon shall be subject to the verification of their original documents by the concerned issuing authorities, if any incorrect information found, he/she is liable for termination of engagement of House Job.

All the selected doctors shown in the above table are advised to report to the office of undersigned alongwith all requisite documents in original as per advertisement notice as mentioned above within 7 days from the date of issue of this order, failing which his/her engagement shall automatically stand cancelled and the next eligible candidate in the merit list shall be considered accordingly. The House Surgeons shall be deemed to have been relieved immediately after completion of their engagement period viz. one year from the date of joining.
