As recommended by the Selection Committee constituted vide Government Order No. 274-HME of 2010 dated 28.04.2010 issued by the Health & Medical Education Department, sanction is hereby accorded to the engagement of the following Doctors as Stipendiary House Surgeons in the Department as shown against each for a period of one year in Indira Gandhi Government Dental College & Hospital, Jammu:

The engagement of House Surgeons will be on tenure basis for a period of one year only and will be subject to the following terms and conditions:


- The House Surgeons will be whole timers and will be non-practising.

- b. During the tenure of House Job, they will be subject to the Rules of Conduct and Discipline on the analogy of other doctors as per the Service Rules.
- c. During the tenure of House Job, they shall not be entitled to any kind of leave except casual leave for 15 days only. The casual leave shall be availed by the doctors proportionately due during the said month. The House Surgeons availing excess of leave during the period of House Job shall have to repeat the same in his/her own interest without any stipend after obtaining prior permission from the Principal, Indira Gandhi Government Dental College, Jammu.
- d. The House Surgeons will receive a consolidated stipend under rules sanctioned by the Government.
- e. The services of the House Surgeons shall be terminated by the Principal, Indira Gandhi Government Dental College, Jammu without prior notice, if he/she indulges in strike or any other activity which is against the interest of institution/patient care and as and when his/her work and conduct is reported to be unsatisfactory by the concerned Head of the Department or any other officer under whom he/she is working.
- f. The stipend of the first month will be kept withheld and will be paid after successful completion of full tenure of House Job.
- g. The House Surgeons selected in various departments will be put on Emergency duties in the Hospital on rotational basis as per the monthly roster issued by the Medical Superintendent, Government Dental Hospital, Jammu. Strict action under rules will be taken against those who do not attend the duties as per roster.
- h. All the house officers are required to submit an affidavit duly attested by the 1<sup>st</sup> Class Magistrate to the effect that:
- He or she has not undergone House Job in any specialty previously within or outside the state and they will abide by the terms and conditions of engagement order and advertisement notice dated 05.08.2017.
  - He or she will not indulge in strike or any other activity which is detrimental to hospital services/patient care during the period of House Job.
  - The engagement as House Surgeon shall be subject to the verification of their original documents from the concerned issuing authorities in case of external candidates other than IGGDC, Jammu. The engagement of House Surgeons whose documents are not found correct shall stand cancelled without any notice.
  - The character and antecedents of the House Surgeons shall be got verified in case of external candidates other than IGGDC, Jammu and if any adverse report is received, his/her engagement as House Surgeon shall stand cancelled.



The candidates are advised to report to the office of the undersigned along with all requisite documents in original as per Advertisement notice issued vide this office endorsement No. IGGDCJ/Estt/GD/Adv/1100-12 dated 05.08.2017 within 07 days from the date of issue of this order, failing which their engagement shall automatically stand cancelled and the next candidate in the merit list of concerned discipline will be considered for engagement. However, the House Surgeons shall be deemed to have been relieved immediately after completion of their engagement period (i.e. one year) from the date of joining.
