Application from the domicile of Union Territory of J&K are invited online from the Dental Surgeons PSC/Non-PSC (unemployed) for the posts of Registrar for tenure of three years in the following disciplines.

Dental College, Jammu on or before **11-06-2020 upto 4 PM**

### Qualification:-

Minimum qualification BDS. (From the institution recognized by DCI).

The candidate having Post graduate degree (MDS) in the concerned discipline mentioned above will be preferred.

### Conditions and Eligibility:-

1. **Incomplete application form(s) in any respect or not attached with relevant certificates shall be rejected without further communication**

a. **For In-Service (PSC) candidates:-**

1. The In-Service Dental Surgeon shall be paid salary as per their LPC..
2. The In-service candidate shall be allowed to participate in the selection process only with the prior permission of the Administrative Department viz. Health & Medical Education Department J&K. For the purpose, they shall route their application forms through Administrative Department and **"no advance copy shall be entertained"**.

b. **For candidates who are not in Govt. Service (NON-PSC candidates)**

1. The Non-PSC candidates shall be engaged on consolidated pay equal to basic pay of Dental Surgeon in the Health Department as per SRO 93 dated 15-04-2009 plus DA

c. **General Condition of eligibility for all candidates:-**

1. The doctor who were earlier appointed as Registrar but has left the job before completing tenure need not to apply.
2. Those BDS/MDS candidates who have already completed their tenure as Registrar in above discipline or any other discipline need not to apply and their application forms shall not be considered.
3. The applications should be accompanied with an affidavit duly attested by the 1<sup>st</sup> class Judicial Magistrate, declaring that the applicant has not done Registrarship earlier within or outside the UT (J&K) in any discipline.
4. The MDS candidates who have completed their registrarship prior to post graduation can apply for the post of registrarship in the concerned specialty.
5. A passport size photograph should be pasted at the appropriate place on the application form.
- d. **The application forms should be accompanied with self attested copies of the following documents/testimonials:-**

- 1) BDS degree from recognized College & University
- 2) Internship completion certificate
- 3) Attempt certificate issued by the Head of Institution/Universities.
- 4) Marks card of all the years of BDS
- 5) MDS degree from recognized College & University
- 6) Rural service certificate (prior to post -graduation) issued by the Director Health services.
- 7) Field service certificate (after post -graduation) issued by the Director Health services.
- 8) Distinction, National Scholarship, Honors, Medals, Academic merit certificate.
- 9) House Job experience certificate for full one year issued by the Principal concerned.
- 10) Professional publication in a standard Medical journal, if any.
- 11) Registration certificate (upto-date) of J&K Dental Council.
- 12) Date of Birth certificate.
- 13) A copy of Aadhar Card
- 14) Domicile certificate/Proof

The eligible candidates shall have to appear for interview before the selection committee in the office chambers of the undersigned along with all original documents for verification.

The selection of the candidates will be made on the basis of combined academic merit and weightage of 90% and 10% in the interview as per the rules/orders issued as per Govt. Order No. 706-HME of 2007 dated 11-01-2007 (Annexure "A")
