As per selection list by the JKSSB vide letter No. JKSSB-SD0SECY(UT)/1/2023-01 (E-7099079) dated 25.01.2024 duly forwarded by Health and Medical Education Department vide letter No. ME-NG/59/2024-02 dated 13.02.2024 and on the satisfactory report from CID vide form No. 97282 dated 26.02.2024, sanction is hereby accorded to the appointment of **Iqra Khursheed D/o Khursheed Ahmad Sheikh R/o 102, Utharpora, Pehlipora, Pahnoo, Shopian, Kashmir, Pin Number 192303, as X-Ray Assistant** in the Pay Level-4(25500-81100) plus allowances as admissible under rules against available vacancy in Indira Gandhi Govt. Dental College and Hospital, Jammu subject to production of the following documents in original.

1. Date of Birth Certificate.
2. Qualification Certificates.
3. Domicile Certificate
4. Medical Fitness Certificate from CMO, concerned
5. That if the candidate has taken loan for self-employment from DIC /Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and counseling Centre of the domicile District. She shall relinquish the proprietorship of unit enterprise and also stakes, if any in such self-employment Unit /enterprise before joining the Government Service. She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from her salary, DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such self-employment unit /enterprise and recovery to be made and also personally monitor it recovery.
6. Relevant category certificate, wherever applicable.
7. Any other document(s) as required under rules.

The appointment of the above said candidate(s) shall be subject to the following conditions: -


1. The appointee shall join within a period of 21(twenty-one) days from the date of issuance of the appointment order. In case the appointee(s) fail(s) to join within a period of twenty-one days from the date of issuance of appointment order, she shall forego her right to appointment which shall be deemed to have been cancelled abinitio without any further notice.
2. Verification/ genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
3. The salary of the appointee shall not be drawn and disbursed to her unless, satisfactory report in respect of above is received in her favour.
4. The appointee(s) shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.

- The appointment in Divisional cadre is non transferable from one Division to another.
- The appointment of the selected candidate(s) shall further be subjected to outcome of writ petition (s) if any, pending on the subject in any court of competent jurisdiction.
- The inter-seniority of the above appointee shall be as per the merit secured by them in the selection process as indicated against each in the select list furnished by the J&K Services Selection Board.

The appointee shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that:

- a) If on verification from the concerned issuing authorities, the qualification certificate/reserved category (whenever applicable) is found forged false or fake, the appointee shall have no claim for appointment.
- b) The appointee shall abide by all the terms & conditions as laid down in their appointment order.
- c) The appointee shall be liable for action as warranted under rules for violating any of the aforementioned conditions as indicated in the appointment order.
