

On the basis of merit obtained by the candidates in MCQ based written test and as recommended by the Selection Committee constituted vide Govt. Order No. 382 JK(HME) of 2024 dated 20.06.2024 for the purpose and in pursuance to Govt. Order No. 383-JK(HME) of 2024 dated 20.06.2024, **Dr. Sheikh Tafazul Habib S/o Habibulllah Sheikh R/o Manigam Vessu, Devsar Kulgam, J&K** is hereby engaged as Registrar against the available vacancy in the Department of Oral & Maxillofacial Surgery, Indira Gandhi Govt Dental College/Hospital, Jammu for a period of one year in the first instance further extendable on year to year basis upto maximum of three years subject to satisfactory work and conduct certificate from the concerned HOD as per rules governing the subject.
