**Sub:- Engagement of doctors as stipendiary House Job Surgeons for the session, 2020-21.**

**ORDER NO. 128 IGGDCJ OF 2020**

**DATED 17 -10-2020**

In pursuance of Govt. Order No. 706-HME of 2007 dated 11-01-2007, modified vide G.O. No. 601-HME of 2007 dated 10-09-2007 with modification vide 726-HME of 2007 dated 23-10-2007 and corrigendum to G.O. No. 726-HME of 2007 dated 23-10-2007 and selection policy pertaining to House surgeons vide Govt. Order No. 706-HME of 2007 dated 11-01-2007 (Annexure C), an advertisement Notice was issued under endorsement No. IGGDCJ/Estt/GD/Adv/1550-61 dated 28-08-2020, a comprehensive merit list was prepared on the basis of academic merit, written test marks. As per merit list and preference given in the uploaded form, counseling of eligible bonafide candidates of this college was conducted. *This engagement of House Surgeons will be on tenure basis for a period of one year only on following terms and conditions.*

1. *The House Surgeons will be whole time basis and will not do any private practice;*
2. *During the tenure period of House job his/her will be governed by rules, regulations, & discipline on the same analogy as is applicable to other doctors of J&K Service Conduct Rules, 1971;*
3. *During tenure of House Job, he/she shall not be entitled to any kind of leave except casual leave for 15 days only. The HOD's shall ensure that the casual leave is allowed in favour of House Surgeon only if it is earned by him/her within the permissible limit of 1.25 days casual leave per month. The HOD concerned shall also ensure that the House Surgeon shall not be allowed to avail the leave not earned by him/her, in case, the House Officer remains absent unauthorized, his/her engagement shall be cancelled forthwith and no House Job certificate shall be issued in that case, However, leave availed on compassionate grounds with documentary evidence could be considered on the basis of recommendations made by the concerned HOD and the repetition order shall be issued at the discretion/approval of the undersigned in this behalf.*
4. *The services of the House Surgeon shall be terminated by the Principal, Indira Gandhi Government Dental College, & Hospital, Jammu without prior notice, if any doctor indulges in strike or any other activity which is against the interest of institution and patient care or unsatisfactory report received from concerned Head of the Department against any of the doctor;*
5. *The stipend for first month shall be kept withheld and the same will be released only after successful completion of full tenure of House Job.*
6. *The House Surgeon shall be put on emergency duties in the hospital on monthly rotational basis issued by the Medical Superintendent, Govt. Dental Hospital, (IGGDC), Jammu and if any House Surgeon found disobeying the orders shall be entitled for termination from the said job under rules;*
7. *The House Surgeons are entitled for stipend as per Government order issued by Health and Medical Education Department, J&K from time to time.*
8. *The House surgeon shall maintain a record of his/her work on a record book.*
9. *He/she shall join the Department within a period of 7 days from the date of issuance of this order, failing which his/her engagement shall stand cancelled without any further notices.*

10. All the House Surgeons shall submit an affidavit duly attested by First Class Judicial Magistrate to the effect that:-

- a) He or she has not undergone House Job in any specialty previously within or outside the State and will not indulge in strike or any other activity which will hamper the hospital service/patient care during the period of House Job.
- b) The engagement as House Surgeon shall be subject to the verification of their original documents, if any incorrect information found, he/she is liable for termination of engagement of House Job.

All the selected doctors shown in the above table are advised to report to the office of undersigned alongwith all requisite documents in original as per advertisement notice as mentioned above within 7 days from the date of issue of this order, failing which his/her engagement shall automatically stand cancelled and the next eligible candidate in the merit list shall be considered accordingly. The House Surgeons shall be deemed to have been relieved immediately after completion of their engagement period viz. one year from the date of joining.
