The post of tutor in the Department of Oral & Maxillofacial Pathology, Indira Gandhi Govt. Dental College, Jammu was advertised vide this office Advertisement Notice issued under endorsement No. IGGDCJ/Estt/GD/1563-70 dated 07.04.2025.

The written test for the same was conducted on 27.05.2025. However as per the directions issued by the Hon'ble Central Administrative Tribunal, ***"the post which was advertised was restrained the respondents from replacing the applicant with another candidate on similar Academic Arrangement Basis for the post of Tutor till the time such post is filled up on substantive basis."***

Now, as per the judgment impugned passed by the Hon'ble Tribunal is set aside and O.As filed by the respondents are dismissed vide WPC Nos. 3230/2025 and 3666/2025 dated 12.03.2026 issued by Hon'ble High Court of J&K and Ladakh at Jammu.

Now, the final merit list of the candidates who have appeared in the MCQ based written test for the engagement of tenure post of Sr. Resident/Tutor in the Department of Oral & Maxillofacial Pathology conducted on 27.05.2025 vide Govt.
