In pursuance to Govt. Order No. 383-JK(HME) of 2024 dated 20.06.2024, applications are invited for the post of Sr. Resident/Registrar in the below mentioned discipline from the eligible candidates for a period of one (01) year in the first instance further extendable on year to year basis up to maximum of three (3) years subject to satisfactory "Work & Conduct" certificate from the concerned HOD:-

The applicants are directed to visit the official website of this institution <http://jobs.iggcdj.edu.in> for completion/submission of their application forms. The detailed instructions for filling up of online form and mode of payment is given in the link provided above on payment of INR. 500/- (Five Hundred only). The link will be available from **30.05.2026 (10:00 A.M) to 13.06.2026 (up-to 05:00 PM)**. For in-service /PSC Dental Surgeons need to take printout of filled application form and route it through proper channel to the office of the Principal & Dean, Indira Gandhi Govt. Dental College, Jammu by or before **13.06.2026 up-to 5:00 PM**. The applicants are advised to upload the following documents along with fee receipt duly self-attested.

**List of documents to be uploaded: -**

1. Date of Birth Proof (10<sup>th</sup> diploma)
2. BDS Degree from NDC recognized College and University.
3. All BDS Marks sheets.
4. Internship completion certificate.
5. Attempt certificate issued by the Head of Institution/University.
6. MDS Degree in concerned speciality from NDC recognized College and University (Mandatory).
7. Registration certificate issued by State Dental Council.
8. Renewal of Registration certificate issued by State Dental Council.
9. Affidavit duly attested from 1<sup>st</sup> class Magistrate declaring that
  - (a) the applicant has not done Registrarship/Demonstratorship/Tutorship/Sr. Residency earlier within or outside the UT (J&K) in any discipline.
  - (b) the applicant has read all the terms and conditions and shall abide the same before he/she is allowed to join after engagement.
10. Domicile Certificate of UT of J&K.
11. A copy of Aadhar card.
12. One passport size photograph should be pasted at the appropriate place on the application form.
13. NOC from Administrative Department Health & Medical Education in case of in-service candidates.


**Terms and Conditions:**

1. The selection for the tenured position of Sr. Resident/Registrar in Indira Gandhi Govt. Dental College, Jammu shall be made on the basis of performance in Multiple Choice Questions (MCQ) based written Test only. The question paper will be of 50 minutes having 50 questions (MCQ based) of 4 marks each. There will be a negative marking of 01 mark(s) for incorrect choice and for opting more than one answer(s). Further zero (0) marks will be awarded for not attempting the question.
2. No application will be accepted beyond cut-off date. The date of the written test shall be notified separately on Indira Gandhi Govt. Dental College, Jammu website. No individual communication shall be made in this regard.
3. The in-service candidates of Health & Medical Education Department shall be allowed to participate in the selection process only with prior permission (NOC) from the Administrative Department. Candidates must route their application forms through proper channel via Administrative Department.
4. The candidates who have already completed their tenure as Registrar/Tutor/Demonstrator/Sr. Resident in concerned discipline in any Dental College or in Dentistry Department of Medical College need not to apply and their application forms shall be rejected.
5. The candidates who are doing Registrarship/Tutorship/Demonstratorship/Sr. Residency in concerned discipline in any Dental College or in Dentistry Department of Medical College need not to apply and their forms will be rejected.
6. The candidate selected on the basis of performance in the Written Test shall:-
  - Submit his/her academic and technical qualification certificates in original, along with one set of self-attested copies of each document, to the office of the Principal & Dean, IGGDC, Jammu at the time of joining.

- Candidates other than in-service candidates are required to submit an affidavit, duly attested by a First Class Magistrate, stating that he/she is neither working nor has worked in any discipline in any Dental College or in Dentistry Department of Medical College as a Registrar/Tutor/Demonstrator/Senior Resident within or outside the Union Territory of Jammu & Kashmir, and that all information provided in the application is true and correct.
7. Candidates are advised not to provide any false information or suppress any material facts, when submitting a hard copy of the application after being shortlisted, they are warned not to alter or tamper with any entry in any document or its attested/certified copy. They should not submit any tampered or fabricated documents. If there is any inaccuracy or discrepancy between two or more such documents or their attested/certified copies, an explanation regarding the discrepancy should be provided.
  8. A candidate who is, or has been, declared by the Selection Committee to be guilty of obtaining wrongful support for their candidature by any means, impersonating or procuring impersonation, submitting fabricated or tampered documents, making incorrect or false statements, suppressing material information, or resorting to any other irregular or improper means in connection with their candidature for election using unfair means during the test, writing irrelevant or obscene content, misbehaving in the examination hall, harassing or causing bodily harm to the staff employed by the Selection Committee for the conduct of the test, or attempting to commit or abetting any of the aforementioned acts, shall be liable to criminal prosecution. Additionally, they may be debarred by the Selection Committee from appearing in the examination, either permanently or for a specified period.
  9. The appointment of the candidate shall be terminable on either side by serving a prior notice of one month or on payment of one month's salary by the appointing authority.
  10. In case of a tie in merit secured by two or more candidates in the written test, the candidate who has scored more marks in BDS shall be given preference. In case, the marks are also same, candidate older in age shall be preferred.
  11. Along with the Select List, a Waiting List shall be maintained, which shall be valid for a period of 3 months, for the relevant discipline. In case of failure of any candidate to join, the next candidate in merit shall be invited to join. No selected candidate who has joined the institution on a tenured position shall be given Experience Certificate if he/she fails to serve on the tenured position for at least six months.
  12. The maximum tenure of a Sr. Resident/Registrar shall be 3 years and no extension shall be granted under any circumstances.
  13. The applicants should have completed BDS/MDS from the institute recognised by NDC. Moreover, candidates having appeared in the final examination of the Postgraduate course (MDS) in relevant discipline/subject are also eligible to apply for the said post in terms of Government Order No. 383-JK(HME) of 2024 dated: 20-06-2024. However, this shall be subject to the condition of production of list of documents as mentioned above alongwith MDS Degree Certificate/MDS Provisional Degree Certificate & valid MDS State Dental Council Registration, evidencing successfully obtaining the requisite qualification within a period of 21 days from the date of issuance of selection list.
  14. The Maximum age for non-service applicants at the time of submission of application should be 50 years as per SO-364, dated 27.11.2020.
  15. The appointee shall be entitled the salary as per relevant rules in vogue.

**Note: All candidates (PSC/Non-PSC) shall also submit the copy of the Application Form complete in all respects alongwith fee payment receipt, list of documents as already mentioned above and Affidavit (in original) in the office of the Principal, Indira Gandhi Govt. Dental College, Jammu by or before 13.06.2026 upto 5:00 P.M.**

**All candidates are directed to produce their original documents on the date of the written test, failing which no candidate will be allowed to appear in the examination.
