Subject: Cancellation of Tender for Providing Hostel Mess Services at IGGDC&H, Jammu.

ORDER

Kindly refer to the e-Bid Notice No: IGGDCJ/EBID/MESS/08; Dated: 03-01-2026 and GeM Bid No. GeM/2026/B/7170040; Dated 31-01-2026, issued for providing Hostel Mess Services at Indira Gandhi Govt. Dental College & Hospital, Jammu.

The salient details of the tender are as under:

- Date of Issue of Tender Notice: 03-01-2026
- Period for Downloading of Bid Documents: 03-01-2026 to 23-01-2026
- Bid Submission Start Date: 03-01-2026
- Bid Submission End Date: 23-01-2026

The technical bids were opened on 25-02-2026, and your firm was found to be technically qualified.

Upon opening of the financial bids, it was observed that ambiguity had arisen regarding the interpretation of the rates quoted on the GeM Portal. The matter was accordingly referred to the GeM authorities for clarification. The GeM authorities have clarified that, as per the prescribed bidding methodology, the financial bid on the GeM Portal is required to be quoted against the total annual contract value and not the per student per day rate.

As per the standard terms and conditions, the total annual contract value is to be calculated as follows:

Rate per student per day × Total number of students × 30 days × 12 months

It has been observed that the financial bid submitted by M/s Chef Hospitality Services, Jaipur, Rajasthan, was quoted on a per day basis instead of the total annual contract value, resulting in a discrepancy in the financial bid and rendering the quoted value incapable of proper evaluation in accordance with the bidding conditions.

In view of the above and to ensure fairness, transparency and equal treatment to all bidders, it has been decided to cancel the present tendering process. A fresh tender shall be floated shortly to eliminate any ambiguity. The fresh tender notice shall be made available on the official website of the College as well as on the GeM Portal, as applicable.
